

- ³ Field calibration service is available for this calibration. Please note the actual measurement uncertainties achievable on a customer's site can normally be expected to be larger than the CMC found on the A2LA Scope. Allowance must be made for aspects such as the environment at the place of calibration and for other possible adverse effects such as those caused by transportation of the calibration equipment. The usual allowance for the actual uncertainty introduced by the item being calibrated, (e.g. resolution) must also be considered and this, on its own, could result in the actual measurement uncertainty achievable on a customer's site being larger than the CMC.
- ⁴ In the statement of CMC, percentages are percent of reading, unless otherwise indicated.
- 5 Based on using the standard at the temperature the Agilent 3458A was calibrated (tcal \pm 5°C) and an auto calibration (ACAL) was performed within the previous 24 hours (± 1 °C of ambient temperature). The CMC is expressed as either a specific value that covers the full range, a combination of the fraction of the reading/output plus a range specification, or as a combination of the fraction of the reading/output plus a fraction of the range specification. For factory traceability to NIST, add 5 μ A/A additional error to AC/DC Current and 2 μ V/V additional error for AC Voltage.
- ⁶ In the statement of CMC, L represents the nominal length of the device in inches; R represents the resolution of the device in microinches.
- ⁷ The measurands stated are generated using the indicated instrument (see Comments). This capability is suitable for the calibration of the devices intended to measure the measurand in the ranges indicated. CMCs are expressed as either a specific value that covers the full range or as a fraction of the reading plus a fixed floor specification.
- ⁸ The type of instrument or material being calibrated is defined by the parameter. This indicates the laboratory is capable of calibrating instruments that measure or generate the values in the ranges indicated for the listed measurement parameter.
